ANNEXURE-II

TERMS & CONDITIONS FOR AADHAR Enabled BIOMETRIC ATTENDANCE SYSTEM

1. The intending tenderers shall have to submit the tenders mentioning detailed specification of the item to be supplied. The Education Block for which the tender is dropped should clearly be mentioned in the envelope containing the tender documents. Separate tenders (including documents and call deposits) should be dropped for each block.
2. The selection of supplier will not be made based on the lowest quoted rate alone. The specifications mentioned in the tenders of the respective tenderer shall also be taken into account while selecting the supplier.
3. The Bank Account Detail, PAN Card, GST registration certificate, Certificate of Govt registered supplier (Certificate has to be renewed if found expired), Upto Date GST Return Copy, Work order of previous supply of AEBAS Machine, Financial Statement of previous Work experience (Minimum 5 previous Work experience order copy for supply of AEBAS machine) shall have to be enclosed along with the tenders.
4. Authorised Dealer certificate from Manufacture will be required for supply of AEBAS Machine in Manufacture Letter head.
5. Attested Copy of BIS/ISO UIDAI (RD) Test Report of AEBAS or other assurance certificate from competent authority and Literature/Catalogue in support of the quoted items.
6. Tenders not fulfilling the above requirements shall be summarily rejected.
7. Supply should be made within 45 Days from the date of issuing supply order. The bills should be inclusive of GST as per quotation. The under-signed shall in no way be responsible for payment of any summary dues thereof.
8. The payment of bills shall be made only on receipt of the required fund from the Deputy Commissioner, Darrang, Mangaldai. The supplier shall not claim the payment from any other Head of Account other than the fund received from the Deputy Commissioner, Darrang, Mangaldai.
9. The supplier has to submit 100% Bill to this office on completion of the project in all the schools. No part payment nor payment for only certain number of schools shall be admissible.
10. 95% of the bill amount shall be made on successful completion of the Supply of AEBAS Machine in all schools. The remaining 5% of fund shall be made on completion of 1(one) year, of the warranty of AEBAS Machine alongwith the Bid security of the successful bidder.
